SECTION 3. The City Council adopts the amendments to the FY 2021 Classification and Pay Plan, which is attached to this ordinance as "Exhibit A." Among other modifications to the existing pay plan, Exhibit A includes an adjustment to pay ranges as recommended by PayPoint HR.

SECTION 4. Except as otherwise provided herein, all unrepresented permanent employees, with the exception of departmental directors, assistant directors, deputy chiefs and assistant chiefs, whose rate of pay is below the pay grade maximum as set forth in Exhibit A shall receive an across the board increase of $2.1 \%$ per hour; provided that, such increase shall be capped at the maximum rate of pay where it would establish or increase a rate of pay above the maximum rate of pay set forth in Exhibit A.

SECTION 5. Following application of the increase set forth in Section 4, all unrepresented permanent employees whose classification is assigned to a pay grade set forth in Exhibit A where the minimum of the pay grade is greater than the employee's current rate of pay shall receive a pay increase to the minimum of the new pay grade set forth in Exhibit A.

SECTION 6. Following application of the increases set forth in Sections 4 and 5 above, all unrepresented permanent employees with three (3) to five (5) years of service as of March 1, 2020 in their current classification shall receive a time-in-classification pay increase as follows:

Three years of service: increase to $40 \%$ of the difference between the new midpoint and the minimum of such classification as set forth in Exhibit A;
Four years of service: increase to $70 \%$ of the difference between the new midpoint and the minimum of such classification as set forth in Exhibit A;

Five years of service:
increase to $100 \%$ of the difference between the new midpoint and the minimum of such classification as set forth in Exhibit A.

SECTION 7. Following application of the increases set forth in Sections 4, 5 and 6 above, all unrepresented permanent employees, with the exception of departmental directors, assistant directors, deputy chiefs and assistant chiefs, with six (6) or more years of service as of March 1, 2020 in their current classification shall receive a time-inclassification pay increase of $0.5 \%$; provided that, such increase shall be capped at the maximum rate of pay where it would establish or increase a rate of pay above the maximum rate of pay set forth in Exhibit A.

SECTION 8. Following application of the increases set forth in Sections 4, 5, 6 and 7 above, all unrepresented permanent employees who are supervisors, shall receive a salary adjustment if such supervisor is making less than $1 \%$ above what the highest paid employee under that supervisor is paid. Such supervisor's salary shall be adjusted such that the supervisor is making $1 \%$ more than the highest paid subordinate; provided that, such increase shall be capped at the maximum rate of pay where it would establish or increase a rate of pay above the maximum rate of pay set forth in Exhibit A.

SECTION 9. The City Manager shall assign employees to appropriate classifications adopted by this ordinance.

SECTION 10. This ordinance shall be in full force from and after its passage and shall be effective as of the pay period beginning April 4, 2021.
