Re: Authorizing Amendment No. 1 to the Waterline Replacement Contract with Consolidated Public Water Supply District No. 1 of Boone County, Missouri relating to the construction of the Sinclair Road, Route K and Old Plank Road Intersection Improvement Project.

Executive Summary

Staff is requesting council authorize the City Manager to execute Amendment No. 1 to the Waterline Replacement Contract with Consolidated Public Water Supply District No. 1 of Boone County, Missouri relating to the construction of the Sinclair Road, Route K and Old Plank Road Intersection Improvement project. The improvement project includes relocating and upgrading the waterline along the north side of Route K during construction of the roundabout.

Discussion

This project will improve long term safety at the Sinclair Road, Route K and Old Plank Road intersection with the construction of a roundabout. Currently, the north leg (Sinclair Road) and the south leg (Old Plank Road) of the intersection are offset from each other. The improvement will align the two legs plus provide other safety features associated with a roundabout, such as slowing the vehicles through the intersection. An Interested Parties meeting was held on May 9, 2019 and the public hearing was held on July 1, 2019

Final plans and specifications were completed by Burns and McDonnell, the engineering consultant for this project. As part of the development of final plans for the project, it was determined that the Consolidated Public Water Supply District No. 1 (District) waterline needs to be relocated to allow for the construction of the roundabout. Bartlett and West designed the waterline relocation and the final design has been included in the construction plans for the roundabout. The City is including the relocation of the District's waterline as outlined in the Waterline Replacement Contract dated October 8, 2020.

The roundabout project was bid in January, 2021 and Emery Sapp and Sons Construction was the low bidder for the project. Since the opening of bids, the District has requested to have the contractor complete some addition waterline improvements utilizing the bid items included in the roundabout bid. Amendment No. 1 to the Waterline Replacement Contract outlines the additional work requested to be performed.

The cost for the additional waterline improvements is \$58,362 and will be reimbursed to the City, by the District.
