Your dept's standing with citizens is at an all-time low, it seems, so you should be considering matters like that to improve community relations while you are attempting to improve your procedures. Keeping the drop-off centers clean is another way to improve your image.

The proposed recycling center at Cosmo Park would not help citizens. There is already a recycling center at the west end of Bus Loop (in front of Moser's) which is practically the same area. That site just needs to be cleaned up/emptied more frequently. Look at your map of sites and see where there is not currently a recycling drop-off: southwest Columbia. South Scott Blvd. I could see arguments for far southeast or far north, as well.

I think the size of this facility is not sufficient. With only five bins this facility will fill up multiple times a day and just lead to more fustration on the part of the public.

Specifically, there are more bins at the Moser 's on the Business Loop and they are overflowing within a few hours of being emptied. For example, I recycled some carboard and containers there a recent Saturday morning at around 0600. The bins were mostly empty. By 1000 when I drove by the bins were once again overlfowing.

I think you should consider setting up a temporary facility in one of the large paking lotts a Cosmos Park. This would include a lot more than five bins. Other temporary sites could be the parking lots at Albert-Oakland Park and Cosmos-Bether Park.
