Re: Amending the FY 2021 Annual Budget by appropriating funds to the Columbia Regional

Airport Terminal Project.

Executive Summary

Amending the FY 2021 Annual Budget by appropriating grant funds in the amount of \$10,763,287 to the Airport Terminal project.

Discussion

In April 2020, the FAA awarded an \$8,000,000 Coronavirus Aid, Relief, and Economic Security Act (CARES Act) grant to the Columbia Regional Airport for reimbursement of airport operational and maintenance expenses for a period of four years, beginning January 20, 2020.

On May 6, 2021, the FAA awarded a development addendum to the CARES Act grant in the amount of \$10,763,287 for reimbursement of expenses related to proposed development at Columbia Regional Airport. These funds will be used toward construction expenses of the new airport terminal facility, and must be spent by April 29, 2024.

Staff is requesting that Council amend the FY 2021 Annual Budget by appropriating the CARES Act development grant funds in the amount of \$10,763,287 to the Airport Terminal Project account.

Fiscal Impact

Short-Term Impact: Appropriating \$10,763,287 to the Airport terminal project account AP111. Long-Term Impact: Grant funds must be spent by April 29, 2024.
