ADMINISTRATIVE PUBLIC IMPROVEMENT PROJECT

Project name and brief description: Hickman Pool Heater Replacement: Park staff is proposing to use contract labor to replace the existing pool heater at Hickman High School swimming pool. During late fall 2020 through early winter 2021, the pool water heater began to fail and despite repeated repairs, would not operate continuously. This resulted in the cancellation of swim lessons, swim team practices and meets. Parks and Recreation maintenance staff worked with two different specialized mechanical contractors, and unfortunately, it was determined that the unit needed to be replaced. The estimated cost range for the purchase and installation of the new pool heater is approximately \$30,000 to \$35,000 depending on the amount of new service, electrical, duct work, plumbing, etc. that has to be replaced during installation. Staff is proposing to upgrade the existing 80% efficiency pool heater to a 98% high efficiency heater. This will reduce the annual operating expenses associated with the pool heater approximately \$6,000 to \$8,000 due to the unit efficiency and reduction in necessary BTUs for the heating of the pool water. The high efficiency heater has a higher initial cost compared to the existing unit but the payback is estimated at 1.23 years due to the annual energy savings. The high efficiency heater also has upgraded parts and new technology to protect internal components from pool water damage. The boiler is isolated from the pool water to avoid damage to the unit and the highefficiency heater uses 100% outside air for burning in the unit. The reduction in annual energy expenses associated with heating the pool water also aligns with the current goals of the City's Climate Action and Adaptation Plan (CAAP). Staff is requesting an appropriation of funds totaling \$35,000 in a separate Council action for this project. The pool heater will be bid through the City's Purchasing Department, and the proposed improvements will be completed using an existing term & supply contractor. Staff anticipates completion of the work by late summer 2021.
