Re: Authorizing the Temporary Closure of Vehicular Lanes, Parking Lanes, and Sidewalk on

Hitt Street between University Avenue and Rollins Street.

Executive Summary

Staff has prepared for Council consideration a resolution authorizing the University of Missouri to temporarily close vehicular lanes, parking lanes, and sidewalk along Hitt Street between University Avenue and Rollins Street through October 1, 2021. The closure is needed to allow construction of chilled water distribution pipe, control conduit, and domestic water utilities serving the campus of the University of Missouri.

Discussion

The University of Missouri has requested to temporarily close vehicular lanes, parking lanes and sidewalk along Hitt Street between University Avenue and Rollins Street through October 1, 2021; staff has authorized the closure for 30 days, beginning May 17, 2021.

The vehicular lane, parking lane, and sidewalk closures include:

- Closure of both vehicular lanes, parking lanes, and sidewalk of Hitt Street through July 16, 2021.
- Closure of the northbound vehicular lane, the east parking lane of Hitt Street, and the sidewalk on the east side of the street from July 16, 2021 through August 10, 2021.
- Closure of the southbound vehicular lane, the west parking lane of Hitt Street and the sidewalk on the west side of the road from August 10, 2021 through October 1, 2021.
 During this closure Hitt Street will be closed to northbound traffic.

The University of Missouri owns all of the property adjacent to the closure. Their contractor, Sircal Contracting Inc., will be constructing chilled water distribution pipe, control conduit, and domestic water utilities serving the campus of the University of Missouri. Staff has reviewed the attached traffic control plans and has no issues with their request.

The University of Missouri and/or its contractor will be responsible for all signs and barricades necessary for the protection and convenience of the general public. The University of Missouri is exempt from any public inconvenience fee.
