Firstly, thnak you for your work, thus far, on this project.

We have lived in our residence for 15 years (May 2006-present), and have experienced the good, the bad, and the ugly of driving behaviours on both sections of Maplewood Drive.

One of the worst places along the street alignment is at the junction of Maplewood (north section) and Rollins. There have been numerous crashes along Rollins at that dog-leg corner; We've had someone plow through our front garden beds; People constantly cut the corner from Eastbound Rollins, to Northbound Maplewood, and from Broadway (westbound) to Maplewood.

Conflicts between vehiculat traffic and pedestrian/cyclist traffic that crosses Maplewood (north section) at the intersection with Rollins is apparent. There are a lot of families with young children, older people, and everyone in between who walk regularily. The intersection is often a place of multi-modal user conflict.

Additional Comments

In addition to the speed humps there should be additional deterrents so drivers don't immediately hit the gas and go the the races up and down the road.

An island that causes the drivers to take a slower, wider turn onto the street would seem an aesthetically pleasing option. It would also help with the identity of the street, and could be mirrored on the southern leg of Maplewood at the junction with Rollins, and the northern junction with Broadway (which has the same cutting issues too).

The speed bumps cannot do the job alone. The cost of a decently curbed native landscaped island (with wheel guards - Neenah R-4986-D) would be useful for the residents of the Maplewood, and would add a sense of place that the speed bumps do not provide.

If the number of speed bumps were reduced in concert to adding islands, we believe the plan is a winner.

Ms. Echols,

I apologize for not responding to your comments sooner. I remember reading your comment when you initially sent it, but it looks like I have not responded.

We are planning on hosting a second Interested Parties meeting virtually the first part of May. Preliminary plans will be presented, and you will have the opportunity to provide additional comments at that time.

At this time, we are considering the installation of a series of speed humps along Maplewood Dr. You are probably correct that this will not result in much reduction to traffic volumes on Maplewood Dr., but speed humps should help to reduce the speeds at the top end of the distribution. I do not have data on whether one-way street conversions result in higher speeds, and most one-way streets in Columbia are narrow enough that lower speeds would be expected in general. I think we would probably see some increase in speeds if Maplewood was converted to one-way due to the road width. Converting streets to one-way may make sense, but it would need to be undertaken as a project to the neighborhood as a whole as any change to traffic flow would impact adjacent streets.

Other traffic volume reducing measures would be possible, but the biggest downsides are they would also affect residents along Maplewood and would push traffic to other streets. The most effective would be closing Maplewood at certain locations, but this would force Maplewood Dr. residents to enter or exit from the same location such as Broadway, and would reduce traffic circulation. Another potential option would be to restrict turns at Broadway with a median island. Again, this would have the largest impact to Maplewood Dr. residents, and would push traffic to parallel streets. Usually, we would only do something like that if there was a crash problem on Broadway.

Overall, I think the speed humps should help reduce speeds closer to the speed limit, which should help to make the street more pedestrian and bicycle friendly. If you have additional questions or comments, please contact me.

Thank you for your reply, I saw the plan for Maplewood and I think the number of speed bumps is good. I notice on other streets that drivers tend to speed up between speed bumps so it is important to have them consistently placed along a street.

I do have concerns how some people try to drive around speed bumps (I see people do this on Rollins) and since there are no sidewalks, this could put cars closer to where pedestrians and bikers and parked cars are. What is your experience with this? Does this occur more with speed bumps or speed humps? Is there anyway to minimize this problem?

I am also wondering if additional signs will be added. My overall opinion is that it would be great to have a comprehensive plan to address multiple issues on the street.

Martha,

The comments will be available to view. These will be included with the supporting documents at the public hearing, and I can provide you with a copy when I put them together.

There may be some drivers who try to drive around speed humps, but I think this mostly happens at speed tables which are used at intersections where there is a little more room for drivers to go around the hump. When we build speed humps, they are built about 2 ft. from the curb, and reach the full height 1 ft. from the edge. This leaves little room to go around the speed hump, and forces drivers to have at least one tire on the full speed hump.

I had submitted comments earlier during the initial comments back in December and I am still not in favor of speed bumps, please see those comments. After looking at the diagrams, I see three speed bumps in the section between Broadway and North Circle and two from North Circle to Rollins. Do we need that many? Wouldn't four be adequate or even three for the entire street? One at the north end of the street, one at the intersection of North Circle and one at the south end of the street. Based on the diagram, one of the speed bumps listed to be in front of 308 Maplewood is actually on or at the edge of 210 Maplewood (my house- 210 and 308 are next to each other). With three cars and a boat /trailer in the driveway we park the two big vehicles on the street and depending on final location, I would end up parking on or just past the speed bump. Having lived on Maplewood for 40+ years, the traffic speed is no better or worse than it has always been. With fewer students living on the west side of town, the traffic is actually not as fast as it used to be. I am not a believer in a solution looking for a problem. Could those funds not be put to better use filling the numerous pot holes around town or some other truly critical road project? You are welcome to call me if you have questions at 573-268-5860.
