Re: Authorizing a Professional Engineering Services Agreement for Materials Testing Services

during the Construction of the Discovery Parkway Extension Project.

#### **Executive Summary**

Staff is requesting council authorize the City Manager to execute a professional engineering services agreement with Allstate Consultants LLC, to provide materials testing services during construction of the Discovery Parkway Extension project. The agreement is for a not to exceed amount of \$37,650. Construction of the project will start mid-June.

#### Discussion

The Discovery Parkway project includes the extension of Discovery Parkway from Discovery Drive to Rolling Hills Road (just south of the intersection of Rolling Hills Road and New Haven Road). Allstate Consultants completed the final plans, specifications, and cost estimate for the project in August of 2020. The project was then bid in January, 2021 and Emery Sapp and Sons (ESS) was the low bidder on the project. This agreement will allow Allstate Consultants LLC to provide materials testing services which are required during construction of the roadway, sidewalk, and bridges.

The professional engineering services agreement is for a not to exceed amount of \$37,650 and will be funded by the 0.25% Capital Improvement Program sales tax. Construction on the project will start mid-June.

#### Fiscal Impact
