Re: Setting a Public Hearing: proposed construction of the Capri Drive Stormwater Management project (SS149)

Executive Summary

Staff has prepared for Council consideration a resolution setting a public hearing on July 6, 2021, concerning the replacement and improvement of public storm drainage infrastructure between Fyfer Place and Capri Drive, on the south side of East Broadway. The project location is shown on the attached Location Map. A virtual interested parties meeting was held for a two week period between May 1, 2021, and May 14, 2021. The resolution estimate for this storm water project is \$284,000 and will be paid from Storm Water Utility funds.

Discussion

This project was identified in the 2015 Stormwater Ballot Initiative, previously known as Rockhill Road drainage, and is located on the existing Capri Drive. The existing storm drainage system is failing, resulting in multiple maintenance calls in recent years and disrupting solid waste service. The proposed improvements include replacing approximately 270 feet of failing Corrugated Metal Pipe (CMP) as well as replacing or adding approximately 50 feet of pipe and 3 inlets. These improvements will improve storm water management in the area. See attached Diagram.

One property on the project is owner-occupied; all the other properties are rentals and are owned by one person. Staff spoke with the two property owners about the project in 2020 and received a favorable response.

A virtual Interested parties (IP) meeting was held May 1, 2021, through May 14, 2021. Staff received no comments during the virtual meeting. See attached IP Contact Log.

The resolution estimate for this storm water project is \$284,000 and will be paid from Storm Water Utility funds.

Fiscal Impact

Long-Term Impact: Reduction in maintenance costs to respond to failures.
