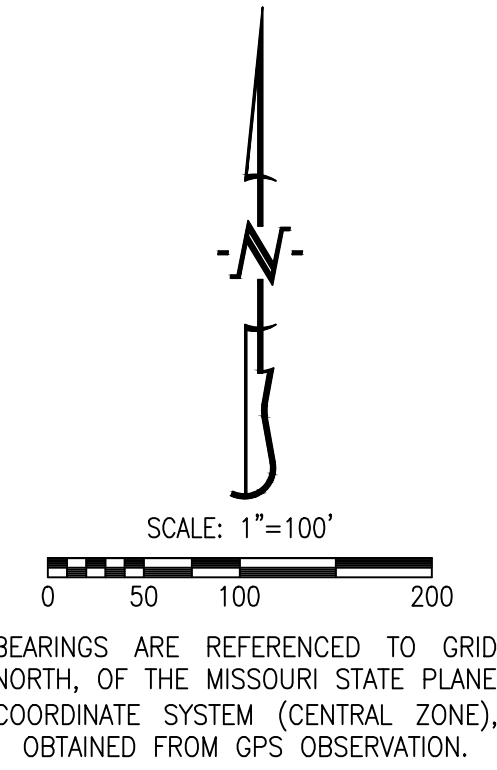


LOCATION MAP
