## MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION SUPPLEMENTAL AGREEMENT TO AIRPORT AID AGREEMENT

THIS AGREEMENT AMENDMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of Columbia (hereinafter, "Sponsor").

## WITNESSETH:

WHEREAS, the parties entered into an Airport Aid Agreement executed by the Sponsor on September 18, 2018, and executed by the Commission on October 5, 2018 (hereinafter, "Original Agreement") under which the Commission granted the sum of Two Hundred Twenty-Nine Thousand Eight Hundred Sixty-Three Dollars (\$229,863) to the Sponsor to assist in Reconstructing Taxiway Connectors A, A1 and A2 Within Runway Safety Areas, and Rehabilitating Portions of Runway 2/20; and

WHEREAS, the Commission previously approved funds for this project; and

WHEREAS, the level of funding originally approved is not sufficient to cover costs associated with this project; and

WHEREAS, the Commission has sufficient funds to increase the grant amount for this project.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

- ADDITIONAL GRANT: The Commission hereby grants to the Sponsor an (1) additional sum of Seven Thousand Three Hundred Seventy-Three Dollars (\$7,373) for this project, which is equal to fifty percent (50%) of the additional match required for the Sponsor's Federal Aviation Administration Grant Number 3-29-0022-046-2018.
- (2)PROJECT TIME PERIOD: Based upon the revised project schedule, the original project time period of October 1, 2020, will be extended to December 31, 2021, to allow for completion of the work. Paragraph (3) of the Original Agreement is hereby amended accordingly.
- ORIGINAL AGREEMENT: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement between the parties shall remain in full force and effect and the unaltered terms of the Original Agreement shall extend and apply to this Supplemental Agreement.
