Re: Amending Chapter 27 of the City Code as it relates to water utility rates

#### **Executive Summary**

Staff has prepared for Council consideration an ordinance amending Chapter 27 of the City Code as it relates to rates charged by the water utility.

#### Discussion

Staff is recommending that Chapter 27 of the City Code be amended to implement a three percent (3%) revenue increase in connection with the August 2018 revenue bond package presented to voters for water utility capital improvements. Included below is a description of the changes to Chapter 27.

#### Chapter 27 proposed changes:

Chapter 27 of the City Code governs the charges paid by customers of the water utility. A three percent increase in revenue from water fees is proposed for the Fiscal Year 2022 budget year, with an effective date of January 2022. This increase is related to coverage of bond indebtedness.

Included below is a list of sections proposed to be changed and the changes.

Sec. 27-122 (a) (1) – Water rates inside city limits – residential/commercial multiple-family facilities:

Rates per one hundred (100) cubic feet (1 ccf), inside city limits:

- All water, beginning with first one hundred (100) cubic feet (1 ccf) from \$2.86 to \$2.95
- Summer water usage for residential customers, except commercial multiple-family facilities and multiple commercial facilities served through a single meter:
  - Usage of zero (0) to seventy (70) percent of winter average consumption from \$2.86 to \$2.95
  - Usage of seventy-one (71) to one hundred seventy (170) percent of winter average consumption from \$4.01 to \$4.13
  - Usage exceeding one hundred seventy (170) percent of winter average consumption from \$6.02 to \$6.20

- Summer water usage for commercial multiple-family facilities and multiple commercial facilities served through a single meter:
  - Usage of zero (0) to seventy (70) percent of winter average consumption from \$2.86 to \$2.95
  - Usage of seventy-one (71) to one hundred seventy (170) percent of winter average consumption from \$4.01 to \$4.13
  - Usage exceeding one hundred seventy (170) percent of winter average consumption from \$6.02 to \$6.20
