Re: Amending the FY2021 Annual Budget by appropriating funds to the Runway 2-20

Extension Project at Columbia Regional Airport

#### **Executive Summary**

The construction of the Runway 2-20 Extension project is currently underway at Columbia Regional Airport. Staff has received a change order in the amount of \$170,779.30 from the contractor for necessary additional work to be performed on the project. The FAA has reviewed the change order and has agreed to reimburse the City 90% of the change order amount.

#### Discussion

A change order to the Runway 2-20 Extension construction contract with Emery Sapp & Sons in the amount of \$170, 779.30, includes electronics and civil changes per the FAA Technical Operation's recommendation. Staff requests to appropriate 90% of this amount, or \$153,701.37 from the federal contributions account, as well as the City's 10% match of \$17,077.93 from transportation sales tax. With this change order, the total construction cost for this project is \$8,896,868.35.

#### Fiscal Impact
