Re: Authorizing construction for the replacement and rehabilitation of a portion of storm drain pipe on Aldeah Avenue, south of Ash Street, calling for bids through the Purchasing

Division or authorizing a contract for work using a term and supply contract.

#### **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the Aldeah Avenue and Ash Street Storm Pipe Rehabilitation Project. The public hearing for this project was held on August 3, 2020. The resolution estimate for this project is \$225,000, and will be paid from Storm Water Utility funds.

#### Discussion

The project will consist of rehabilitating and replacing the storm drain pipe from the southeast corner of Aldeah Avenue and West Ash Street intersection to the back yard of 104 Aldeah Avenue. See the attached location map. Approximately 170 feet of the system will be removed and replaced, and 330 feet rehabilitated in place. See the attached project graphic.

Staff anticipates utilizing the term-and-supply bidding process for this project. This ordinance authorizes constructing the improvements through the City's term-and-supply contracts or bidding through Purchasing, as necessary. An interested parties meeting was held August 21, 2019. A public hearing was held for this project on August 3, 2020. The resolution estimate is \$225,000 and will be paid from Storm Water Utility funds.

#### Fiscal Impact

Short-Term Impact: Resolution estimate is \$225,000 paid from Storm Water Utility enterprise revenue.

Long-Term Impact: Initial reduction and long term minimal impact on annual operating costs.
