Mr. Zenner asked that I follow up with you. On Monday the City recieved two requests for this property: a rezoning to office (M-OF) and a concurrent one-lot subdivision plat.

Attached are the informational postcards I am mailing out next week.

At this time, the two cases are tentatively scheduled to be heard by the Planning Commission on October 7 (7 PM, City Hall, 701 E. Broadway). Public comments may be made to the Planning and Zoning Commission for their consideration, and may be provided in writing to myself prior to the meeting. You are also encouraged to attend and speak at the meeting as well.

Are there any specific questions I may answer regarding the requests or the review process? The applications indicate the desire for an office building to be built; as building and site plans have not been submitted at this time, I am not able to confirm details related thereof. Mr. Hagan indicated to me that he was speaking with the neighbors, and I would encorage you to speak with him about his plans (I belive you have his contact information but am able to provide it if desired). Develoment proposals within the City are subject to stream buffer, stormwater and other applcable environmental and development related reguations.
