Executive Summary

Authorizing a bid call through the Purchasing division for the construction of City of Columbia Fire Station #11, to be located on lot 53 of Deerfield Ridge Subdivision, north of the intersection of Scott Boulevard and State Route K. A virtual Interested Parties (IP) meeting was held July 12, 2021 through July 23, 2021, and an in-person IP meeting was held on August 9, 2021. The Public Hearing for the project was held on September 7, 2021

Discussion

Staff is requesting Council authorize a bid call through the Purchasing Division for the construction of City of Columbia Fire Station #11. Following is the project timeline to date:

City of Columbia Fire and Public Works department staff began a search for property in this area in late 2018, as the project was approved by City of Columbia City Council for the fiscal year 2019 budget.

At the June 1, 2020 City Council meeting, Council authorized the purchase of 2.5 acres located off Scott Boulevard, Lot 53 Deerfield Ridge Subdivision, Plat No. 2, for the new station. Funding for the land was secured with Capital funds, a purchase price of \$347,027 was negotiated, and the contract was approved at this meeting.

At the December 21, 2020 meeting, Council authorized a professional architectural services agreement with Peckham and Wright Architects d/b/a PWArchitects Inc. (PWA) for design services related to the construction of the facility. PWA was selected based upon their experience and expertise designing public safety facilities.

A virtual IP meeting was held July 12, 2021 – July 23, 2021 and received two (2) comments, one (1) in support of the project and one (1) wanting a mini-library to be built in the southwest part of town. An in-person IP meeting was held August 9, 2021 in Conference Rooms 1A/1B of City Hall.

A Public Hearing was held September 7, 2021 whereby Council directed staff to proceed with final plans and specifications for the construction of the facility.

The total project investment (design, utilities, construction, and construction administration) is \$2,500,000. The project will be funded with Capital Improvement Sales tax (CIST).
