A RESOLUTION

authorizing the City Manager to execute FY 2022 agreements with various arts and cultural organizations; authorizing agreements of up to \$500 per agreement for arts programming or services for cultural organizations.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute agreements with the following arts and cultural organizations in the following amounts:

SECTION 3. The City Manager is authorized to execute additional agreements in FY 2022 for arts and cultural programming upon the recommendation of the Cultural Affairs Commission; provided, that the amount of any such agreement shall not exceed \$500.00 and the total amount of such agreements shall not exceed \$3,000.00.
