Re: Local Parks Sales Tax Extension

Executive Summary

An ordinance has been prepared that would extend the local parks sales tax approved by the voters on November 2, 2021.

Discussion

On November 2, 2021, the voters approved an extension of the local parks sales tax for a period of ten (10) years by a vote of 7,203 in favor and 1,761 against Proposition 1. An ordinance has been prepared that would extend the local parks sales tax as approved by the voters to fund projects in the City's parks, recreation and open space master plan including land acquisition for parks, greenways and natural areas, maintenance improvements to existing parks and facilities, annual funding for equipment replacement and program scholarships, new facility and park development, land acquisition for trails and greenbelts and capital improvement projects for such, and contingency purposes.

Fiscal Impact

Short-Term Impact: Extension of the 1/8-cent Park Sales Tax will generate approximately \$30.9 million dollars for improvements to the City's parks and recreation system over the ten (10) year period.
