MEMORANDUM OF FIRST AMENDMENT TO PCS ANTENNA AGREEMENT

This Memorandum of First Amendment to PCS Antenna Agreement is made effective this
day of, 2021 by and between CITY OF COLUMBIA, a municipal
corporation, (hereinafter referred to as "City") and T-MOBILE USA TOWER LLC, a Delaware
limited liability company, by and through its Attorney In Fact, CCTMO LLC, a Delaware limited
liability company (hereinafter referred to as "Lessee").

- 1. City and Lessee entered into a PCS Antenna Agreement dated November 19, 2013 (the "Agreement"), whereby Lessee leased certain real property, together with access and utility easements, located in Boone County, Missouri from City (the "Leased Premises"), all located within certain real property owned by City ("City's Property"). City's Property, of which the Leased Premises is a part, is more particularly described on Exhibit A attached hereto.
- 2. The Agreement had an initial term that commenced on June 7, 2015 and expired on June 6, 2020. The Agreement provides for two (2) extensions of five (5) years each, one (1) of which was exercised by Lessee (each extension is referred to as a "Renewal Term"). According to the Agreement, the final Renewal Term expires June 6, 2030.
- 3. City and Lessee have entered into a First Amendment to PCS Antenna Agreement (the "First Amendment"), of which this is a Memorandum, wherein the Leased Premises was expanded by an additional area of 20.2 square feet. Additional details of the foregoing expansion are contained in the First Amendment.
- 4. The terms, covenants and provisions of the First Amendment shall extend to and be binding upon the respective executors, administrators, heirs, successors and assigns of City and Lessee.
