TMP-23290 Budget Recommendations

Eric Hempel shared a spreadsheet with the commission that included budget recommendations that CEC members had made, along with last year's CEC budget recommendations that have not yet had funding allocated for.

Members discussed the potential budget recommendation item of installing heat pumps in municipal buildings, external funding opportunities, transit improvements, and municipal energy efficiency improvement efforts.

Members discussed how to prioritize their recommendations. Members discussed grouping the recommendations into the following categories: CAAP implementation, energy, and transportation.

Members specified requesting 18 shelters for transit (6 per route), and requesting \$5,000 for education on energy efficiency programs.

It was suggested that the process for making FY 2025 budget recommendations should start in October of this year.

Motion that the Climate and Environment Commission adopt the items reflected in lines 5 through 10 as their recommendations for budget priorities for the City Council for FY 2024: Leanne Tippett Mosby
