I. CALL TO ORDER

Andrea Waner called the meeting to order at 5:31 p.m.

III. APPROVAL OF AGENDA

refresh existing members. Brian Jones announced that he is working on the plan and hopes to have it ready for review next month as old business.

VI. NEW BUSINESS

Public Transportation - Andrew Grabau, United Way

Andrew Grabeau of the United Way shared the United Way's efforts on their journey to inclusive excellence and their thoughts on public transportation with an equity lens. Andrew Grabeau announced a financial stability and economic mobility summit event on Thursday, November 8, 2018. Andrew Grabeau will plan to attend the January meeting to discuss this topic further.

Review of Chapter 12A of the City Code

The Commission discussed its review of Chapter 12 A of the City Code and noted the following: three gender pronouns. Scott Dean suggested that someone let Councilperson Skala know that the Human Rights Commission has already reviewed the City Code for equity issues because Councilperson Skala mentioned that the scope of services for an upcoming contract may involve review of the city code for equity issues. The Commission decided to review the first two articles of Chapter 27 for the next meeting to review the CASH and Help programs, shut offs, and deposits, in addition to a general review of equity.
