#### **VIII. NEW BUSINESS**

Staff presentation of the remaining changes began with #19 of the photocopied list of significant changes created by staff. The remainder of the list of 45 changes was presented to the committee.

• Items #21, 22, 24, 25, 29, 33, and 45 were selected or further discussion.

## X. GENERAL COMMENTS BY PUBLIC, MEMBERS AND STAFF

- #21: NEC Article 406.12 The list of places that required tamper-resistant receptacles has been greatly expanded;
- 22: NEC Art. 406.15 Dimmer switches are no longer permitted to control receptacles.
- 24: Art. 422.16 B2 (6) The receptacle for a built-in dishwasher shall be located in the space adjacent to the space occupied by the dishwasher.
- 25: Art. 680.12, 680.14 The wiring methods and materials for swimming pools must be listed and identified for corrosive environments.
- Question: Are Liquidtight Flexible Metal Consuit (Seal-Tight) and/or Liquidtight
  - Non-metallic Conduit (Carflex) listed and identified for corrosive environments?
- 29. Art. 300.5 D4 Electrical Metallic Tubing is now permitted to protect conductors in underground installations. Question: Has the chemical composition of EMT changed?
- 33. Article 600.6 A1 Exception No.2 Location of Disconnects for Electric Signs. Some discussion regarding disconnects for signs to be located inside the building and not

at the sign.

45. Art 700.10A Emergency Systems Circuit Wiring. Discussion centered on clarification that all components of the Emergency Systems circuit wiring be identified with red color or red marking.
