III. APPROVAL OF AGENDA

Thad Yonke made a motion to approve the agenda as presented, with a second by Mike Henderson. The motion passed unanimously. (6-0)

V. PROPOSED CATSO AREA FUNCTIONAL CLASSIFICATION CHANGES

Mitch Skov gave an overview of the item. The revisions include the removal of four future road corridors shown on the map, given that there are no immediate plans for the construction of these potential new roadways. Also included in the revision package are fourteen reclassifications of existing roadways to better reflect their current functionality.

A committee member questioned the reasoning for the proposed revision to upgrade Smiley Lane (Providence to Route 763) from Major Collector to Minor Arterial, given that Smiley Lane east of Route 763 is designated as a collector street. As the Providence Road minor arterial terminates at Smiley Lane, the presumption is that designating this section of Smiley as a minor arterial continues that functionality to Route 763(Rangeline Street).

Henderson made a motion to forward the proposed FC Map revisions to the Coordinating Committee with the Technical Committee's comments noted. The motion was seconded by Yonke. The motion passed unanimously. (6-0)

VI. DISCUSSION - DRAFT 2050 LONG-RANGE TRANSPORTATION PLAN

Skov noted that the 2050 LRTP was in final draft format and that a number of comments had been received on the comment sheets available at the September 18, 2019 public meeting and open house. Additional comments were received via email. The majority of the comments suggested placing additional emphasis on non-motorized transportation options and on the bus system, including allocating a greater share of projected revenues to those modes of transport.

The Committee pointed out a number of minor corrections, including needed labeling revisions, etc. Skov indicated that he would review the entire document once more prior to sending out the CATSO Coordinating Committee agenda for the December 5, 2019 meeting, which will include a public hearing on the LRTP. Henderson made a motion to forward the draft 2050 LRTP to the Coordinating Committee with minor corrections made, and also to document any major revisions in a separate document to be included in the meeting agenda packet. The motion was seconded by Yonke. The motion passed unanimously. (6-0)
