Review of FY2020 Signature Series Applications

The Tourism Development Signature Series applications were reviewed, discussed and scored to determine funding levels for FY2020.

The top three scoring events; True/False Film Fest, Show-Me STATE GAMES and Roots & Blues & BBQ Festival were recommended for \$12,500, and an additional \$7,500 for marketing purposes only. \$10,000 was recommended for Art in the Park, University Concert Series and We Always Swing Jazz Series.

Motion made by Hargrove to fund True/False Film Fest, Show-Me STATE GAMES and Root & Blues & BBQ Festival at \$12,500 with an additional \$7,500 for marketing only and \$10,000 to Art in the Park, University Concert Series and We Always Swing Jazz Series. The 2020 post event reports should specifically detail how the additional \$7,500 marketing was spent. Strodtman seconded the motion. Motion carried.
