I. CALL TO ORDER

The meeting was called to order at approximately 6:01 p.m.

This item is open to the public: Discussion regarding the American Rescue Plan Act.

The Council discussed the process for distributing funds for the American Rescue Plan Act. Stephanie Browning, Public Health and Human Services Director - (Community Health Improvement Plan) CHIP plan every five years - was present and described the process used during this effort. She pointed out that the process used was very time consuming. Stephanie indicated that the Health Department doesn't have the capacity to lead this effort at this time. She explained that the analysis is labor intensive and to prepare an actual report for Council is time consuming.

Council Member Waner indicated that she had reviewed a proposal from the City of Durham, NC. She explained that they used \$100,000 to hire an outside consultant to conduct the process. Ms. Waner drafted a timeline for the process to begin around October.

In summary, the Council discussed the best path forward in terms of the process for distributing these funds, including the possibility of hiring a consultant to administer the process. Council Member Waner will forward the timeline/research to Council for review.
