Re: Public Hearing for the remodel of the repurposed Automated Flight Service Station

Building at Columbia Regional Airport.

Executive Summary

Public hearing concerning the proposed construction of improvements for the redesign of the former Automated Flight Service Station building at the Columbia Regional Airport to be used for airport administration offices, car rental space, and Transportation Security Administration (TSA) offices, at Columbia Regional Airport.

Discussion

In August 2022, the Purchasing Division issued a Request for Quotations for services related to the design of the repurposed Automated Flight Service Station (AFSS) building located just south of the new Airport terminal. This facility will eventually house airport administration offices, car rental space and the future Transportation Security Administration (TSA) offices.

An Interested Parties meeting was held at City Hall on August 10, 2022, with two individuals in attendance with no objections.

In March of 2023, Burns & McDonnell Engineering Company, Inc. was awarded the contract for services related to the design of the AFSS facility at a cost of \$322,550.00. A Supplemental Agreement No. 1 with Burns & McDonnell was authorized by Council on August 21, 2023 for additional services not included in the original contract for an additional \$55,725.

The Resolution estimate for this project is \$4.8M and will be paid from the Terminal Project AP111 with City Council approval to proceed, construction will begin this summer.

Fiscal Impact

Short-Term Impact: Improvement costs for the remodel of the AFSS building are estimated to cost \$4.8M for construction and engineering construction phase services, to be paid from the Terminal project AP111.
