# **Executive Summary**

A resolution authorizing the City Manager to sign two (2) contract amendments with In2Action.

### Discussion

The City currently holds three agreements with In2Action: (1) Roof Replacement Project, previously approved for \$100,000, (2) Respite House Project, previously approved for \$550,000, and (3) Vocational Training Program, previously approved for \$100,000.

Following receipt of the final costs for the roof project, the total amount required is \$73,252, which is \$26,748 less than originally allocated. The Respite House project, however, requires additional funds to meet identified needs.

The proposed amendments make the following adjustments: (1) the Roof Project Amendment decreases the contract amount from \$100,000 to \$73,252, and (2) the Respite House Amendment increases the contract amount from \$550,000 to \$576,748.

The reallocation results in a net cost of zero, as no additional City funds are required.
