Re: Setting a public hearing for the construction of the Garth Ave improvement project.

Executive Summary

Staff has prepared for Council consideration a resolution setting a public hearing for April 21, 2025 for the construction of the Garth Ave improvements between Texas Ave and Thurman St. The initial interested parties meeting for this project was held on August 8, 2023 and a second interested parties meeting was held on February 26, 2025. The total project cost estimate for design, easement acquisition, and construction is \$1,627,700.

Discussion

Garth Ave improvements is a major maintenance street and sidewalk project to be completed between Texas Ave and Thurman St. This project will include reconstruction of failing pavement panels, curbs, and sidewalk sections in various locations along Garth Ave. The project will also include the construction of new sidewalk on the east side of Garth Ave, filling in the two sidewalk gaps between Texas Ave and Thurman St. Finally, the project will include an asphalt overlay along Garth Ave between Texas Ave and Thurman St.

The initial interested parties meeting for this project was held on August 8, 2023. Seventeen citizens signed in at the initial meeting and 8 written comments were received. Comments were in support of the road and sidewalk improvements with concerns about the impacts to the existing trees and vegetation. There were also comments requesting traffic calming for the corridor.

Between the first and second interested parties meeting, staff completed the topographic survey and designed the preliminary plans for the improvements. The preliminary plans include the pavement, curb, and sidewalk repairs and the new sidewalk to fill in gaps along the east side of the road. The plans also include sidewalk bump-outs at various intersections to match the existing bump-outs at Phyllis Ave and at Leslies Ln. The bump-outs provide traffic calming and safety by narrowing the roads at the intersection and providing a shorter distance for pedestrians to cross the road. Speed humps are not recommended to provide traffic calming for the corridor because Garth Ave serves as a north-south traffic corridor allowing both everyday traffic and emergency responders to reach locations throughout the community. While speed humps can be beneficial, they must be balanced with their potential impact on emergency response times. Speed humps are typically more suitable for residential streets with lower traffic volumes, where they have minimal effect on emergency response.

The second interested parties meeting was held on February 25, 2025. Twenty-two citizens signed in at the second meeting and 10 written comments were received. Comments were

generally in favor of the project, especially the pedestrian improvements. There were some concerns with loss of trees and vegetation from the proposed sidewalk construction. There were also some comments about bicycle symbol and the pedestrian crossings.

The total project cost estimate for design, easement acquisition, and construction is \$1,627,700. The project will be funded with the ¼-cent capital improvement program sales tax and the county road tax funds. Construction on this project is currently scheduled to begin in the summer of 2026.

Fiscal Impact

Short-Term Impact: The total project cost estimate is \$1,627,700 and will be funded with the ¼-cent capital improvement program sales tax and the county road tax.

Long-Term Impact: Sidewalks will be maintained by the adjacent property owners.
