## ROAD RELINQUISHMENT AGREEMENT

THIS AGREEMENT is entered into by the County of Boone ("County") and the City of Columbia ("City").

## WITNESSETH:

WHEREAS, the County owns Old Plank Road in Boone County as part of the County roadway system; and

WHEREAS, the City desires to accept the portion of the roadway of Old Plank Road as further described herein in to the City roadway system; and

WHEREAS, the County is agreeable to relinquish and convey the Roadway that is the subject of this Agreement to the City.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in the Agreement, the parties agree as follows:

- (1) CONSIDERATION AND PURPOSE: The purpose of this agreement is to set for the terms and conditions of the conveyance of the County's Roadway that is the subject of this agreement. The consideration for entering into this Agreement by the parties is the City's willingness to accept ownership of the subject Roadway.
- (2) WORK BY CITY: Upon relinquishment or conveyance of the roadway to the City, the City shall perform the following:

New pavement, 1/2 bulb cul-de-sac

(3) LOCATION: The general location of the roadway to be conveyed is as follows:

The general location is shown on "Exhibit A", attached hereto and made a part of this Agreement.

- (4) RELINQUISHMENT: Prior to the completion of the work as specified in paragraph (2), the County shall convey to the City that portion of the County roadway which is the subject of this Agreement by quitclaim deed releasing any and all interest the County has in the property referred to in "Exhibit A". The exact legal description of the roadway shall appear in the quitclaim deed. The City agrees to accept this deed from the County. The deed shall be filed with the office of the Recorder of Deeds in Boone County.
- (5) CLAUSES IN THE DEED: The following clauses will be included in the quitclaim deed from the County to the City, where in the County is referred to as "Grantor" and the City is referred to as "Grantee":
  - a. The Grantee, by acceptance of this conveyance, covenants and agrees for itself, its successors and assigns, to allow known or unknown utility facilities currently located on the property whether of record of not, to remain on the property, and to grant the current and subsequent owners of those facilities the right to maintain, construct and reconstruct the facilities and their appurtenances over, under, and across the land herein conveyed, along with the right of ingress and egress across the land herein conveyed to and from those utilities.

- b. By conveyance through this quitclaim deed, the County makes no claim to the resulting title of the above-described property and is merely releasing whatever interest it has to the Grantee.
- (6) MAINTENANCE BY COUNTY: Upon conveyance of the roadway to the City, any of the County's responsibilities to maintain the roadway shall cease and the roadway will no longer be considered a part of the County roadway system.
- (7) MAINTENANCE BY CITY: The City shall maintain the roadway as part of the City's system.
- (8) COUNTY REPRESENTATIVE: The County's <u>Presiding Commissioner</u> is designated as the County's representative for the purpose of administering the provisions of this Agreement. The County's representative may designate by written notice other persons having the authority to act on behalf of the County in furtherance of the performance of this Agreement.
- (9) LAW OF MISSOURI TO GOVERN: This Agreement shall be construed according to the laws of the State of Missouri.


