WHEREAS, on August 13th, 2024, the Commission and the City previously entered into a Transportation Alternatives Program Agreement as to public improvements designated as TAP 2104(506), for the construction of sidewalks along Broadway from Maplewood Drive to West BLVD, (hereinafter, "Original Agreement"); and

WHEREAS, the Commission and the City now desire to revise the Original Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and representations contained herein, the parties agree as follows:

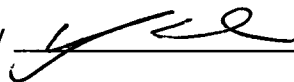
