### **Executive Summary**

Staff has prepared for Council consideration a Resolution authorizing the City Manager to sign the Seventh Amendment to the Software License and Services Agreement between the City of Columbia, Missouri and Central Square Technologies, LLC.

### Discussion

This amendment will allow Central Square to migrate the Field Training data from the on premise servers to the cloud. The needed update for the Field Training module is running version 15.00.2101 database. That version is not compatible with the City of Columbia's server which is running 11.00.7512. The migration to the cloud would eliminate on premise upgrades and would allow The City of Columbia to receive updates to the Field Training module on a regular basis.
