FIRST AMENDMENT to the 2024 FUNDING AGREEMENT

This First Amendment to the 2024 Agreement between the City of Columbia, Missouri, a municipal corporation (hereinafter "City"), and IN2ACTION, a nonprofit corporation of the State of Missouri (hereinafter "Agency") is made as of the date of the last signatory noted below ("Amendment Effective Date").

RECITALS

- A. WHEREAS, on or about April 18, 2024, City and Agency entered into a Funding Agreement associated with the renovation of a group home for people with substance abuse disorder on property located at 2501 Eastwood Drive ("2024 Agreement"); and
- B. WHEREAS, the Parties hereto desire to formally amend the 2024 Agreement with this First Amendment (hereinafter "First Amendment") and desire to be bound by the terms contained in the 2024 Agreement as amended or supplemented by those terms contained in this First Amendment.

AMENDMENT

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the 2024 Agreement, as follows:

- 1. Section 3.a. is hereby amended by deleting the phrase "FIVE HUNDRED AND FIFTY THOUSAND DOLLARS (\$550,000.00)" therefrom and by inserting the phrase "FIVE HUNDRED AND SEVENTY-SIX THOUSAND SEVEN HUNDRED FORTY-EIGHT DOLLARS (\$576,748,00)" in lieu thereof.
- 2. Exhibit A is hereby amended by deleting all references to the number "\$550,000" therefrom and inserting the number "\$576.748" in lieu thereof.
- 3. All other terms of the 2024 Agreement shall remain unchanged and in full force and effect.
