Re: Authorizing a Special Event Operations Agreement with The Boone County Fair, Inc. for the 2025 Boone County Fair.

Executive Summary

This resolution authorizes the operations agreement for the Boone County Fair, July 15, 2024 through July 20, 2025 at the Northeast Regional Park located at 5212 North Oakland Gravel Road, Columbia, Missouri.

Discussion

The Boone County Fair, Inc., has submitted a Special Event Permit application for the 2025 Boone County Fair. Set up will begin July 11, 2025 from 8:00 a.m. until 5:00 p.m. The fair will operate from July 15, 2025 through July 19, 2025 from 5:00 p.m. until 10:00 p.m. Clean up will be completed by Sunday, July 21, 2025 at 10:00 p.m.

The City Special Events Committee has worked closely with the Boone County Fair Board members to address all aspects of the event and to develop and implement plans including but not limited to: festival layout, traffic & public safety plans, alcohol management plans, insurance, solid waste plans, accessibility plans, food service plans and entertainment plans.

Because of the size and scope of the fair and the requirement of city services and equipment, an agreement must be executed between the city manager and event organizer and approved by City Council per Section 24-73(b) of the City Code.

The Special Events Committee will continue to work with the organizers prior to the start of the event, including a walk-through inspection to ensure all aspects of the Operations Agreement are met and approved by the appropriate city staff.
