In looking at the proposed plan we do feel the need for something like speed bumps to slow the motorists who use Russell Blvd; however we wonder if the number of such traffic calming devices may be excessive. There appears to be five such proposed bumps on the street, some of them just a few hundred feet apart. To us this seems more than necessary to slow down traffic, but we do not have the expertise that your traffic engineers have. If it is possible to have fewer speed bumps we'd be more than 100% in agreement with the plans; otherwise we'll deal with proposal if this is best plan possible.


