Council Meeting September 2, 2025:

1. **Council Bill 184-25:** Amending Chapter 27 of the City Code as it related to electric services and rates **(Approved)**
2. **Public Hearing 26-25:** FY 2025 Annual Budget for the City of Columbia
3. **Council Bill 183-25:** Adopting a budget for the City of Columbia, Missouri for the fiscal year October 1, 2025, through September 30, 2026 (FY 2026); providing that certain amounts shown in the budget document are appropriated for the various departments specified in said budget.**(Public input/Table and vote September 15, 2025)**
4. **Council Bill 221-25:** Amending the FY 2025 Annual Budget by appropriating funds to refund an overpayment received from the Midcontinent Independent System Operator (MISO) to the City's Electric Utility **(Approved)**

3. **Resolution 137-25:** Authorizing an agreement for professional engineering services with Leidos Engineering, LLC for local and regional dynamic system modeling and transient stability analysis of the City's electric transmission system.
