## 2025-2029 CONSOLIDATED PLAN AND 2025 ANNUAL ACTION PLAN FY 2025-2029 CITIZEN PARTICIPATION PLAN

The Columbia City Council will hold a public hearing during the Housing and Community Development Commission meeting at 7:00pm on June 25,2025, and on July 7, 2025 at 7:00 p.m. in the Council Chambers of City Hall, 701 E. Broadway, to consider the City's 2025-2029 Consolidated Plan, 2025 Annual Action Plan and Fy 2025-2029 Citizen Participation plan. Copies of the draft document are available at 11 N 7th st Columbia MO. and at [Como.gov/housing-programs-division](http://Como.gov/housing-programs-division). Following the July 7, 2025 hearing, public comments will be accepted until 5:00 P.M. July 11,2025. The final document will be submitted to the U.S. Department of Housing and Urban Development for approval along with public comment received and responses to those comments. The City of Columbia receives CDBG and HOME funding from the U.S. Department of Housing and Urban Development (HUD) according to its population, demographics and the federal formula for distributing funds. The City is required to submit a Consolidated Plan at least every five years. The 2025-2029 Consolidated Plan identifies community development needs and funding priorities for the next five years. The 2025 Annual Action Plan is the first year's plan for expenditure of funds in the five year cycle. The FY2025 funding to include approximately **\$1,127,222.00** of Community Development Block Grant funding and **\$794,915.77** of HOME Investment Partnership Act Funding. Proposed CDBG and HOME activities for 2025 plan period are listed below.
