Executive Summary

Authorizing the City Manager to make application and execute all necessary documents for Columbia Regional Airport capital assistance grants throughout calendar year 2026 from the United States Department of Transportation Federal Aviation Administration (FAA) and the Missouri Department of Transportation (MoDOT).

Discussion

This legislation is an annual renewal of the City Manager's authorization to make application for DOT, FAA and MoDOT grants, submit required certifications and assurances, execute grant offers and supplemental grant amendments, and submit any other required information on behalf of the City of Columbia and Columbia Regional Airport. This legislation also authorizes the Airport Manager, or appointed designee, to furnish additional grant related information required by the United States Department of Transportation FAA and MoDOT, and to review and submit electronically to the United States Department of Transportation FAA and MoDOT grant applications, quarterly reports and other required information, on behalf of the City of Columbia and Columbia Regional Airport.
