Re: Supplemental - Municipal Agreement with the Missouri Department of Transportation (MoDOT) regarding improvements to the I-70 corridor from the Missouri River to Paris Road (Route B) within Columbia.

Executive Summary

Authorize the City Manager to execute the Municipal Agreement the Missouri Department of Transportation (MoDOT) prepared for the City of Columbia regarding improvements to the I-70 corridor from the Missouri River to Paris Road (Route B) within Columbia.

This agreement was included on the December 15, 2025 council meeting agenda as an introduction and first reading item. MoDOT has revised the agreement to include additional streets and correct some of the street names following detailed discussions with the City of Columbia. This revised agreement reflects the changes. No other revisions have been made to the agreement.

Discussion

MoDOT is pursuing improvements to the I-70 corridor from the Missouri River to Paris Road (Route B) within Columbia.

MoDOT acknowledges the importance of bicycle and pedestrian facilities to the City within the agreement. They will encourage the Design-Build Contractor to consider connectivity for pedestrian and bicycle movement through the corridor and in the surrounding area when designing the project. Detailed plans for pedestrian and bicycle improvements to the Interchange areas will be provided to the City for review, and the City may provide MoDOT with comments for consideration.

The City will grant MoDOT the right to use the right-of-way of public roads and streets owned by the City in the location of the improvement. The City will allow temporarily closure of all streets or roads, or parts thereof, which may be necessary to permit the construction of the project in accordance with the detailed plans. The City will be notified a minimum of ten (10) calendar days in advance of any road or street closures during construction. Local traffic may be allowed, if practical, at the discretion of MoDOT's Project Director.

Fiscal Impact

Short-Term Impact: Some possible utility relocation costs for utilities within existing MoDOT right of way.
