Krista Shouse-Jones provided comparative data on serious injury and fatal traffic accidents involving pedestrians and bicyclists occurring

YTD in 2024 relative to 2023. The Commission learned that MODOT has \$1 million in annual funding available to address vulnerable user needs in the Central District. The FY 2026 and FY 2027 funding is allocated for Columbia.

B. Parks & Recreation Report

Janet Godon reported that the Parks Department is hoping to replace Bridge Number 9 and repair Bridge Number 10 on the MKT Trail.

Mitch Skov agreed to provide a list of potential projects. Elke Boyd asked the Commission to review and consider priorities. Frank Schmidt asked that the Commission plan to discuss this item at the March 2024

meeting.
