Re: Business Loop CID Board of Directors – Membership Change due to Resignation

## Executive Summary

The Business Loop Community Improvement District (CID) Board of Directors has submitted a proposed Board of Director member to the Mayor for consideration for appointment due to the resignation of Suzi McGarvey.

## Discussion

The Business Loop CID was established by ordinance on April 20, 2015, and it provided for seven Board of Directors members. The initial seven members were appointed by the ordinance establishing the Business Loop CID to staggering terms of two and three years.

The qualifications to serve on the Board of Directors are set out in the Business Loop CID petition and state law. It is required that each director be at least 18 years of age and be either an owner of real property within the District, an owner of a business operating within the District, or a registered voter residing in the District, all as defined in the CID Act (67.1401 RSMo. et seq.)

The petition governing the formation of the Business Loop CID provides for the appointment process of members to the Board of Directors. Upon submission of a slate of proposed successor directors by the Business Loop CID Board of Directors to the Mayor, the Mayor (with the consent of the City Council) shall approve the appointments or request alternates be submitted. The approval or request for alternates is required to occur within 30 days of the submission of names by the Business Loop CID.

If there is a request for alternative names, the Business Loop CID Board of Directors shall resubmit the slate with alternates, and the Mayor shall choose appointees from the names submitted and seek the consent of the City Council. If the City Council refuses to consent to the slate, within ten days, the Mayor shall request alternatives from the Business Loop CID Board of Directors.
