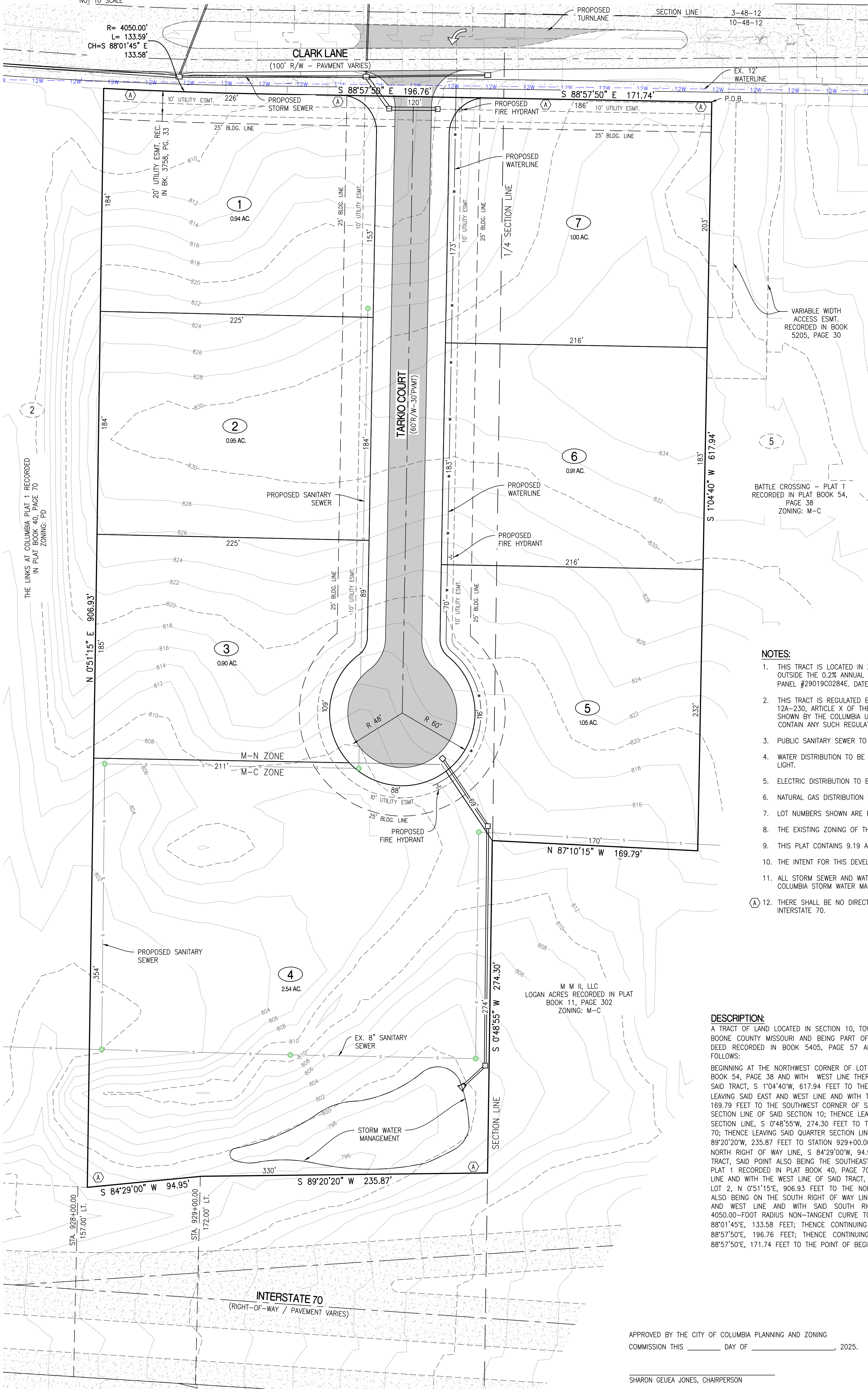
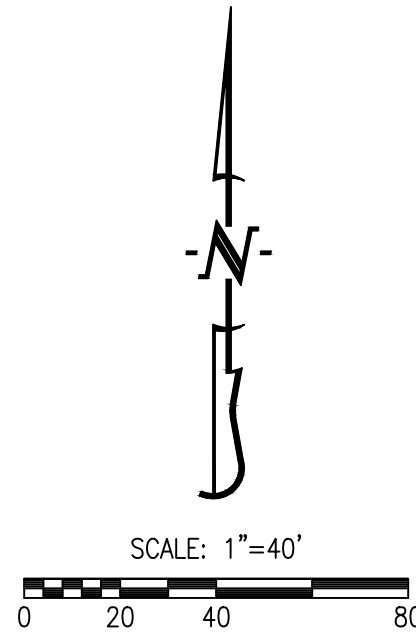

- THIS TRACT IS REGULATED BY THE STREAM BUFFER REQUIREMENTS IN SECTION 12A-230, ARTICLE X OF THE CITY OF COLUMBIA CODE OF ORDINANCES AS SHOWN BY THE COLUMBIA USSS QUADRANGLE MAP. THIS TRACT DOES NOT CONTAIN ANY SUCH REGULATED STREAM BUFFER.

DESCRIPTION:

A TRACT OF LAND LOCATED IN SECTION 10, TOWNSHIP 48 NORTH, RANGE 12 WEST, COLUMBIA, BOONE COUNTY MISSOURI AND BEING PART OF A TRACT OF LAND DESCRIBED BY TRUSTEE'S DEED RECORDED IN BOOK 5405, PAGE 57 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 5, BATTLE CROSSING - PLAT 1, RECORDED IN BOOK 54, PAGE 38 AND WITH WEST LINE THEREOF, SAID LINE ALSO BEING THE EAST LINE OF SAID TRACT, S 1°04'40"W, 617.94 FEET TO THE SOUTHWEST CORNER OF SAID LOT 5; THENCE LEAVING SAID EAST AND WEST LINE AND WITH THE SOUTH LINE OF SAID TRACT, N 87°10'15"W, 169.79 FEET TO THE SOUTHWEST CORNER OF SAID TRACT, SAID POINT BEING ON THE QUARTER SECTION LINE OF SAID SECTION 10; THENCE LEAVING SAID SOUTH LINE AND WITH SAID QUARTER SECTION LINE, S 0°48'55"W, 274.30 FEET TO THE NORTH RIGHT OF WAY LINE OF INTERSTATE 70; THENCE LEAVING SAID QUARTER SECTION LINE AND WITH SAID NORTH RIGHT OF WAY LINE, S 89°20'20"W, 235.87 FEET TO STATION 929+00.00, 172.00 LEFT; THENCE CONTINUING WITH SAID NORTH RIGHT OF WAY LINE, S 84°29'00"W, 94.95 FEET TO THE SOUTHWEST CORNER OF SAID TRACT, SAID POINT ALSO BEING THE SOUTHEAST CORNER OF LOT 2, THE LINKS AT COLUMBIA PLAT 1 RECORDED IN PLAT BOOK 40, PAGE 70; THENCE LEAVING SAID NORTH RIGHT OF WAY LINE AND WITH THE WEST LINE OF SAID TRACT, SAID LINE ALSO BEING THE EAST LINE OF SAID LOT 2, N 0°51'15"E, 906.93 FEET TO THE NORTHWEST CORNER OF SAID LOT 2, SAID POINT ALSO BEING ON THE SOUTH RIGHT OF WAY LINE OF CLARK LANE; THENCE LEAVING SAID EAST AND WEST LINE AND WITH SAID SOUTH RIGHT OF WAY LINE, 133.59 FEET ALONG A 4050.00-FOOT RADIUS NON-TANGENT CURVE TO THE LEFT, SAID CURVE HAVING A CHORD, S 88°01'45"E, 133.58 FEET; THENCE CONTINUING ALONG SAID SOUTH RIGHT OF WAY LINE, S 88°57'50"E, 196.76 FEET; THENCE CONTINUING WITH SAID SOUTH RIGHT OF WAY LINE, S 88°57'50"E, 171.74 FEET TO THE POINT OF BEGINNING AND CONTAINING 9.18 ACRES.
