At the Climate and Environment Commission's April 25 meeting, Greg Coffin presented a summary of the Water and Light Advisory Board's deliberations and actions with respect to electric rates, followed by a presentation from Jim Windsor on an alternative rate proposal. The commission appreciated hearing this information from Mr. Coffin and Mr. Windsor. As part of its role in overseeing implementation of the Climate Action and Adaptation Plan, the Commission adopted the following statement:

The Climate and Environment Commission urges City Council to request a summary of the effects of the new rate proposal on rate affordability for low-income residents and/or disparate impacts, and long-term total emissions.

TMP-24181 Electric Rate Structure - Gregg Coffin, Water and Light Advisory Board

Gregg Coffin spoke to the Climate and Environment Commission about the history of the cost of service and rate study. Topics that Coffin covered included the following: the Water & Light Advisory Board's review process and trainings, the utility's financial needs, the findings of the cost of service and rate study, rate affordability, impacts of COVID, rate classes, the inverted block rate's ability to encourage energy conservation, and causes of cost increases.

Members asked questions about demand, electric vehicles charging, utility assistance programs, residential cost increases, and AMI.

TMP-24218 Alternative Electric Rate Proposal- Jim Windsor

Jim Windsor, a member of the community and former City employee, presented his disagreements with the rate design and the findings of the consultant. Windsor discussed disagreements with the assumptions used by the consultant and issues with the base charge. Windsor stated his prediction that the costs would disproportionately be paid by customers who use the least and that the proposed rate would not encourage efficiency. Windsor encouraged the Climate and Environment Commission (CEC) to advocate for the creation of an alternative rate proposal from the consultant's proposal.

Dick Parker handed out a typed recommendation for the CEC to make to City Council, attached as "Proposal by Dick Parker."

Members discussed the suggestion of an alternative proposal, including the lack of information and expertise that the commission has to make recommendations, the importance of rates being monitored for impact on climate and incentivizing energy efficiency, and the timing of the City Council's decision making on the rates.

Leanne Tippet Mosby made a motion that was discussed by the commission. The motion was amended, discussed, and withdrawn.

Jessica Norris made a new motion, then amended that motion. The commission discussed and passed the motion.

Godwin encouraged commission members to sign up for the newsletter.

Eric Hempel's staff report included the following: The rental energy efficiency project update will be presented at the next City Council meeting as a report; Hempel will be attending the building energy codes conference in Chicago in May; MEEA is hosting an energy efficiency commercial training in May at the Daniel Boone Regional Library; and there will be Show Me the Heat community stakeholder meeting in late May organized by Community Resilience Organizer and Community Conservationist.
