Improvements Project infrastructure grant with the Missouri Department of Natural Resources for State Fiscal Recovery Funds under the American Rescue Plan Act (2021); amending the FY 2025 Annual budget by appropriating funds.

#### Executive Summary

Staff has prepared for Council consideration an amendment of an ordinance authorizing the award of the Stormwater Improvements Project in the amount of \$2,219,928.20 from the Missouri Department of Natural Resources for State Fiscal Recovery Funds under the American Rescue Plan Act (2021). The ordinance authorizes the Grants Administrator, Andrew Wyatt, to sign the grant agreement and the appropriation of grant funds to eligible projects.

#### Discussion

On June 6, 2022, Council passed Resolution 81-22 which authorized the Grants Administrator, Andrew Wyatt, to execute and file an application on behalf of the City of Columbia with the State of Missouri for American Rescue Plan Act Water Infrastructure Community Grant Programs through the Missouri Department of Natural Resources. The initial grant request was for drinking water, wastewater and stormwater infrastructure improvements. In November 2022, the Missouri Department of Natural Resources provided a notice of award for the following stormwater projects and funding amounts:

On December 18, 2023, Council approved a partial Award Agreement for engineering services for the Calvert Drive Stormwater Improvements Project. The construction portion of

the project was recently bid, therefore the award agreement is to be amended to the full amount of the expect award. Exhibit A to the Ordinance is the full award agreement for the Calvert Drive Stormwater Improvement Project. This grant award, totaling \$2,810,035.70, includes a Federal portion of \$2,219,928.20 and a City match of \$590,107.50. The grant requires an 80/20 percent match. The City's 20 percent match and any additional required funding for construction will be from Storm Water Utility funds. To be reimbursed with the MDNR ARPA funds, all construction must be completed by December 31, 2026. Emery Sapp & Sons, Inc. was the successful bidder for \$2,988,216.50. The total construction bid includes \$92,354.00 for waterline relocation work, paid for by Stormwater Utility funds, and \$68,912.00 for sanitary sewer relocation work, paid for by Sewer Utility funds.

Fiscal Impact

Short-Term Impact: \$2,219,928.20 from MDNR ARPA funds; \$607,022.30 from Storm Water Utility funds; \$68,912.00 from Sewer Utility funds; \$92,354.00 from Stormwater Utility Funds for waterline relocation work.

Long-Term Impact: Increased annual costs to the Stormwater Utility for maintaining the detention basin. Work can be accomplished with current staffing and operations budget.
