



GENERAL NOTES

TRAFFIC CONTROL DEVICES SHALL COMPLY WITH THE MUTCD.
CONTRACTOR SHALL MAINTAIN A MINIMUM LANE WIDTH OF 12' AT ALL TIMES FOR ANY OPEN LANE OF TRAFFIC.
CONTRACTOR SHALL REFER TO THE CURRENT EDITION OF THE MUTCD MANUAL OF TRAFFIC CONTROL FOR FIELD OPERATIONS FOR INFORMATION ON THE PROPER DEPLOYMENT OF TRAFFIC CONTROL DEVICES.
CONTRACTOR SHALL KEEP ALL ADJACENT DRIVEWAYS OPEN AT ALL TIMES.
CONTRACTOR SHALL NOTIFY CITY OF COLUMBIA COMMUNITY PRIOR TO ANY CLOSURE MADE ACCORDING TO THIS PLAN. ALL TIMES FOR CLOSURE SHALL BE APPROVED BY THE CITY OF COLUMBIA PRIOR TO IMPLEMENTATION OF THIS PLAN.
CONTRACTOR IS RESPONSIBLE FOR NOTIFYING THE RED RIGHT OF WAY TECHNICIAN (874-7474), IMMEDIATELY PRIOR TO CLOSURE OF STREET, DURING CONSTRUCTION FOR INSPECTIONS AND AGAIN WHEN WORK IS COMPLETE AND STREET IS REOPENED.

	PLACE STANDARD HIGHWAY SIGN (MUTCD SIGN # W11-4L). SIGN SHALL BE 24" X 24" MIN.
	PLACE STANDARD HIGHWAY SIGN (MUTCD SIGN # R9-11L/R SHOULD READ "SIDEWALK CLOSED AHEAD CROSS HERE"). SIGN SHALL BE 24" X 18" MIN.
	PLACE STANDARD HIGHWAY SIGN (MUTCD SIGN # R9-9 SHOULD READ "SIDEWALK CLOSED"). SIGN SHALL BE 24" X 18" MIN.
	CHANNELIZER CONE/MARKER. 36" TALL MIN.
