Executive Summary

The Business Loop Community Improvement District (CID) is submitting its end of fiscal year report, which is required by State Statute.

Discussion

The Business Loop CID was established by ordinance on April 20, 2015. Pursuant to Section 67.1471.4 of the Revised Statutes of Missouri "Within one hundred twenty days after the end of each fiscal year, the district shall submit a report to the municipal clerk and the Missouri department of economic development. The report shall state the services provided, revenues collected, and expenditures made by the district during such fiscal year; state the dates the district adopted its annual budget, submitted its proposed annual budget to the municipality, and submitted its annual report to the municipal clerk; and include copies of written resolutions approved by the board during the fiscal year. The municipal clerk shall retain this report as part of the official records of the municipality and shall also cause this report to be spread upon the records of the governing body."
