AN ORDINANCE

accepting conveyances for sewer, utility, underground utility, and drainage and utility purposes; accepting Stormwater Management/BMP Facilities Covenants; directing the City Clerk to have the conveyances recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City of Columbia accepts the following conveyances:

Grant of Easement for sewer purposes associated with a sewer extension project located in the general vicinity of Becky's Bluff Court, from Russell L. and Sally C. Powell, dated February 13, 2024, a copy of which is attached to this ordinance.

Quit Claim Deed for sewer purposes associated with construction of Fox Creek Subdivision located in the general vicinity of Mexico Gravel Road and Route PP from JR2 Development LLC, dated July 31, 2023, a copy of which is attached to this ordinance.
