Re: Flat Branch Park Expansion Project – Bridge Fabrication and Installation

#### **Executive Summary**

The Parks and Recreation Department is requesting approval of a resolution to set a public hearing for the fabrication and installation of the bridge needed for the Flat Branch Park expansion project. The department is also requesting approval to use a design/build contract for the design and fabrication of the bridge. On March 15, 2021, City Council conducted a public hearing and approved the Flat Branch Park expansion project. Since the project approval, Park staff and Allstate Consultants, LLC. have completed all necessary work related to the park design and placement of the bridge connecting the two sections of Flat Branch Park. Staff is ready to proceed with the bidding of the bridge for the trail project through the City's Purchasing Department. The design/build process is common for bridges because most bridges are pre-fabricated with bridge design and fabrication completed by the same vendor. Emery Sapp & Sons has agreed to construct the end walls for the bridge and set the bridge in place at no charge to the City of Columbia. Staff anticipates completion of the bridge installation by late summer 2023.

#### Discussion

On March 15, 2021, City Council approved the Flat Branch Park capital improvement project and appropriated funds to complete the proposed work. Since that date, park staff and Allstate Consultants, LLC. have been working on site cleanup, creek restoration and engineering related to the installation of the bridge that will connect the two sections of the park. Additional fundraising was completed by the Mayor's Task Force for the Bicentennial Celebration and those funds, totaling \$85,000, were appropriated to the capital improvement project at the September 19, 2022 City Council meeting.

Park staff is ready to move to the next phase of the project including the bidding of the bridge design and fabrication through a design/build contract and installation of the bridge by Emery Sapp & Sons.

The Parks and Recreation Department is requesting approval of a resolution that would set a public hearing for the fabrication and installation of the bridge needed for the Flat Branch Park expansion project and authorizing the use of a design/build contract for the bridge design and fabrication.

The construction of the Flat Branch Park expansion project includes the installation of one bridge, approximately 60 feet in length, across the Flat Branch Creek. Allstate Consultants, LLC. has completed all preliminary work associated with bridge construction and installation including topographic cross-sections for floodway evaluation, floodway analysis of the

proposed bridge location and FEMA approval of the crossing. Allstate Consultants, LLC. has also provided design criteria for the design/build scenario for the bridge including abutment elevations, span lengths and necessary geotechnical studies.

With all necessary information related to the conditions for the bridge installation and additional funding appropriated for the bridge, staff is ready to proceed with bidding the design/build Flat Branch Park bridge project through the City's Purchasing Department. The selected vendor will complete the design of the bridge, utilizing the information provided by Allstate Consultants, LLC., fabricate the bridge and delivery the bridge to the site. Emery Sapp & Sons has agreed to construct the end walls for the bridge and complete the bridge installation at no charge to the City. A plaque will be placed at the bridge in memory of Justin Gay, long-time employee of Emery Sapp & Sons. Staff anticipates the completion of the bridge installation by late summer 2023.

### Fiscal Impact

Short-Term Impact: The total cost of the improvement project is \$585,000 and is funded by the 2015 Park Sales Tax and donations. The acquisition of the bridge will be funded out of this project budget. Staff estimates the cost of the bridge will be between \$150,000 and \$175,000.
