Re: Setting a public hearing to consider amendments to the FY 2025-2029 Consolidated Plan, FY 2025 Annual Action Plan, FY 2025-2029 Citizen Participation Plan and the Annual Action Plans for FY 2019, FY 2023 and FY 2024

Executive Summary

A public hearing is needed to consider amendments to the City's 2025-2029 Consolidated Plan, 2025 Annual Action Plan and FY 2025-2029 Citizen Participation plan, as well as amending the FY 2019 Annual Action Plan, FY 2023 Annual Action Plan, and FY 2024 Annual Action Plan.

Discussion

The attached resolution seeks Council approval to set a public hearing on July 7, 2025 for considering amendments to the FY 2025-2029 Consolidated Plan, FY 2025 Annual Action Plan (AAP), FY 2025-2029 Consolidated Plan and the FY 2019, FY 2023 and FY 2024 Annual Action Plans. A public comment period was established from June 6, 2025 until July 11, 2025 at 5:00 pm. A public hearing will be held on June 25 at the Housing and Community Development Commission (HCDC) meeting to review and approve these plans.

On May 14, 2025 Mayor Buffalo received notification from the U.S. Department of Housing & Urban Development that the City of Columbia would receive our fiscal year 2025 allocation Community Development Block Grant (CDBG) and Home Investment Partnership Program (HOME) funding. The City of Columbia's Fiscal Year 2025 allocations include \$1,065,222 in CDBG funds and \$493,820.06 in HOME funding. Now that these amounts are confirmed, adjustments to proposed funding activities for the FY 2025-2029 Consolidated Plan and 2025 Annual Action Plans need approval by City Council. This allocation is more than was anticipated. Significant changes include increased funding for acquisition and demolition to support development of new affordable housing, administration and planning, home ownership assistance and to support Community Housing Development Organizations (CHDO).

Staff proposes amending the Citizen Participation Plan, Section C, item i.v., to allow for funding changes up to \$125,000 on eligible activities before requiring an amendment to the Annual Action Plan. Previously, this item specified that any change of 10% or more required an Annual Action Plan amendment. The benefit of this change is greater flexibility and reduced administration, particularly for smaller dollar projects. Staff reviewed Citizen Participation Plans from Kansas City, MO; Springfield, MO; Davenport, IA, Lawrence, KS and Missoula, MT where additional flexibility was provided for funding changes.

The Annual Action Plans for FY 2019, FY 2023 and FY 2024 are being amended to allow for reallocation of funds from projects that were not completed or generated from program income. Reallocations include \$60,668.22 in CDBG-CV Funds, \$530,000 in CDBG and \$400,000 in HOME Funds. The public notices that were published in the *Columbia Missourian* on June 5, 2025 have been included as attachments.

HCDC and City Staff recommend amending the FY 2019, FY 2023, and FY 2024 Annual Action Plans consistent with the below:

The 30-day public comment period will end July 11, 2025 at 5 p.m. Any comments received will be included within the documents submitted to HUD.

Fiscal Impact

Short-Term Impact: FY2025 fund allocation of \$1,065,222 in CDBG funds and \$493,820.06 in HOME funding; \$990,668.22 in reallocated funds will distributed via agreements later this calendar year.

Long-Term Impact: Approximately \$7,350,000 over 5 years for affordable housing and housing program activities.
