Re: Columbia Community Land Trust – City of Columbia Agreement Renewal

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing a one-year Agreement for the Administrative Services Agreement between the City of Columbia and the Columbia Community Land Trust (CCLT). The current agreement, which has been extended four times, expires on December 31, 2025. Staff is recommending approval of a one-year Agreement to enable the CCLT and city staff to continue planning as to the CCLT's future endeavors

Discussion

On December 31, 2025, an Administrative Services Agreement between the City of Columbia and the CCLT will expire unless renewed. The agreement, originally authorized by the City Council in January 2017 and last extended for one year in December 2024, provides for City staff support of the CCLT. The proposed Agreement will extend the period to December 31, 2026.

The Administrative Services Agreement initially established in 2022 instituted the collection of an administrative services fee for the administrative duties (preparation of real estate closings; paying invoices; collection of ground lease payments; arranging for property maintenance; assistance to auditors, etc.) that should not be charged to the Community Development Block Grant (CDBG) or HOME investment Partnerships (HOME) administrative accounts. Section 20 of the original agreement stated that no administrative fees were to be charged by the city for the period of three years from the effective date of the agreement (January 2017-January 2020). The amended agreement provided for up to \$20,000 to be provided to the City to offset CCLT-related administrative duties. This fee arrangement will continue in 2026.

On November 5, 2025, the CCLT Organization Board approved a motion to recommend a one-year Agreement of the Administrative Services Agreement with the city.

Fiscal Impact
