

**FOURTH AMENDMENT
to the
2024 AGREEMENT**

This Fourth Amendment to the 2024 Agreement between the **CITY OF COLUMBIA** ("CITY"), and FIRST LAST MILE VALET SERVICE, ("Provider") is made as of the date of the last signatory noted below ("Amendment Effective Date").

RECITALS

- A. WHEREAS, on January 17, 2024, CITY and Provider entered into an Agreement for transportation services ("2024 Agreement"); and
- B. WHEREAS, on February 6, 2024, the Parties entered into a First Amendment to the 2024 Agreement ("First Amendment"); and
- C. WHEREAS, on December 17, 2024, the Parties entered into a Second Amendment to the 2024 Agreement ("Second Amendment"); and
- D. WHEREAS, on August 5, 2025, the Parties entered into a Third Amendment to the 2024 Agreement ("Third Amendment"); and
- E. WHEREAS, the Parties hereto desire to formally amend the 2024 Agreement with this Fourth Amendment (hereinafter "Fourth Amendment") and desire to be bound by the terms contained in the 2024 Agreement as previously amended and as amended or supplemented by those terms contained in this Fourth Amendment.

AMENDMENT

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the 2024 Agreement, as previously amended, as follows:

- 1. Section 8 is hereby amended to add the following subsection (g):
"g. Provider is in need of additional start-up funding in the amount of fifty-five thousand one hundred thirty-two dollars and seventy-six cents (\$55,132.76). City will pay the start-up funding within fifteen days of the Fourth Amendment Effective Date. Provider shall use the start-up funding only for eligible and allowable costs in accordance with the American Rescue Plan Act of 2021, and related rules, regulations and guidance. The costs must be reasonable, allocable and properly documented."
- 2. All other terms of the 2024 Agreement, as amended, shall remain unchanged and in full force and effect.
